

ORDINANCE 2018- 10

WATER RATES AND LATE FEES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MANSFIELD, PIATT COUNTY, ILLINOIS, AS FOLLOWS:

SECTION I

This ordinance shall amend chapter 38-2-1 of the Mansfield Village Code and any ordinance passed heretofore relating to such operation is hereby repealed to the extent that such ordinance is in conflict with the provisions hereof.

SECTION II

38-2-2 Residential Service. Beginning January 1, 2019 the flat monthly user fee shall be \$22/month. It will increase on this schedule: \$24/month beginning January 1, 2020; \$26/month beginning January 1, 2021; \$28/month beginning January 1, 2022; \$30/month beginning January 1, 2023. If a meter is installed the user fee for such service shall be equal to the flat monthly fee. The remaining provisions are not changed.

38-2-3 Business Service. Beginning January 1, 2019 the flat monthly user fee shall be \$22. It will increase on this schedule: \$24/month beginning January 1, 2020; \$26/month beginning January 1, 2021; \$28/month beginning January 1, 2022; \$30/month beginning January 1, 2023. If a meter is installed the user fee shall be equal to the flat monthly fee. The remaining provisions are not changed.

38-2-4 Industrial Service. Beginning January 1, 2019 the user fee shall be \$22. It will increase on this schedule: \$24/month beginning January 1, 2020; \$26/month beginning January 1, 2021; \$28/month beginning January 1, 2022; \$30/month beginning January 1, 2023. The remaining provisions are not changed.

38-2-6 Maintenance Charges. The charge for one man and backhoe shall be \$65 per hour. The remaining provisions are not changed.

38-2-9 Non-Resident Service. Beginning January 1, 2019 the user fee shall be \$25. It will increase on this schedule: \$27/month beginning January 1, 2020; \$29/month beginning January 1, 2021; \$31/month beginning January 1, 2022; \$33/month beginning January 1, 2023. The remaining provisions are not changed..

This ordinance shall take effect on January 1, 2019 upon its passage, signing, recording, and publication in pamphlet form as provided by law.
