**An Ordinance Amending the Liquor Ordinance to
Allow 3 Class "A" Liquor Licenses within the Municipality**

WHEREAS, pursuant to the Illinois Municipal Code and the Illinois Liquor Control Act, 235 ILCS 5/4-1, the Village Board of Trustees has the authority to determine the number of Class "A" licenses to be issued within the Village.

WHEREAS, the Village Board of Trustees upon a duly noticed hearing considered whether to increase the amount of Class "A" liquor licenses within the Village.

WHEREAS, the Village Board of Trustees determined that it would not harm the public or be a public safety concern if the amount of Class "A" liquor licenses was increased from two to three.

WHEREAS, the Village Board of Trustees determined that increasing the number of Class "A" licenses would economically benefit the Village.

NOW BE THEREFORE IT ORDAINED THE VILLAGE OF MANSFIELD LIQUOR ORDINANCE BE AMENDED AS FOLLOWS:

21-2-6 CLASSIFICATION - FEE - LIMITATION. Every person engaged in the retail sale of alcoholic liquor in the Municipality shall pay an annual license fee. Such licenses shall be divided into the following five (5) classes:

(A) Class "A" License: Taverns. A Class "A" tavern license shall grant the holder thereof the privilege of selling alcoholic beverages at retail to members of the general public for consumption on the licensed premises and not in the original container and for consumption off of the licensed premises in the original container. The annual license fee for a Class "A" license shall be Eight Hundred Dollars (\$800.00) which may be paid in two (2) equal six (6) month installments. There shall be no more than ~~two (2)~~ **three (3)** Class "A" licenses issued.
