Ordinance No. 2020- 09

AN ORDINANCE AMENDING THE VILLAGE OF MANSFIELD CHAPTER 21 CODE OF ORDINANCES "LIQUOR CODE" TO REQUIRE PERSONS UNDER THE AGE OF 21 BE ACCOMPNAIED BY A PARENT OR GUARDIAN UPON A CLASS A OR CLASS B LICENSED PREMISES AFTER 9P.M. EXCEPT THOSE PERSONS EMPLOYED BY THE LICENSEE

WHEREAS, the Village Board of Trustees may from time to time to amend Village Ordinances in the interest of the health of safety of the residents of the Village of Mansfield.

WHEREAS, that the Village Board determined that holders of Class A and Class B licenses often host family oriented and veterans events that persons under the age 21 should be able to attend without a legal parent or guardian.

WHEREAS, the current Liquor Code does not allow persons under the age of 21, at any time, to enter upon Class A or Class B licensed premises without a parent or legal guardian.

WHEREAS, the Village Board of Trustees determined that the Chapter 21 of the Village of Mansfield Code of Ordinances (hereinafter referred to as "Liquor Code") should be amended to allow persons under the age 21 be accompanied by a parent or legal guardian upon Class A or Class B Licensed Premises only after 9p.m.

WHEREAS, the Village Board of Trustees further determined that the provisions regarding 9pm should not apply to those persons under the age of 21 employed by the Licensee.

NOW BE IT THEREFORE ORDAINED, the Board of Trustees of the Village of Mansfield AMEND the Liquor Code as follows:

21-3-21 **UNDERAGED; ENTRY ON LICENSED PREMISES.** It shall be unlawful for any person under the age of **twenty-one (21) years** to enter upon premises where alcoholic liquors, spirits, beer or wine are sold by the holder of a Class "A" or a Class "B" license **AFTER 9:00 pm**, unless accompanied by a parent or legal guardian. No holder of a Class "A" or Class "B" license, nor any officer, associate, member, representative, agent or employee of such licensee shall permit any person under the age of **twenty-one (21) years** not accompanied by a parent or legal guardian to enter the licensed premises **AFTER 9:00 pm**. For the purpose of preventing the violation of this section, any holder of a Class "A" or a

Class "B" license, or his agent or employee, may refuse to permit entry onto the licensed premises of any person under the age of **twenty-one (21) years** who is unable to produce adequate written evidence of the fact that the person accompanying such person under the age of **twenty-one (21) years** is that person's parent or legal guardian. (235 ILCS 5/4-1). **This Provision shall not apply to those persons employed by the Licensee.**

THAT this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
