AN ORDINANCE PROHIBITING WIND FARMS, AND ELECTRIC-GENERATING WIND DEVICES WITHIN 1.5 MILES RADIUS SURROUNDING THE ZONING JURISDICTION OF THE VILLAGE OF MANSFIELD.

WHEREAS, the corporate authorities have the power to regulate wind farms and electric generating wind devices within the 1.5 mile radius surrounding the zoning jurisdiction pursuant to 65 ILCS 117-3-25.

WHEREAS, the corporate authorities held a public hearing on this ordinance pursuant to the notice and hearing requirements of 65 ILCS 117-3-25.

AN ORDINANCE PROHIBITING WIND FARMS, AND ELECTRIC-GENERATING WIND DEVICES WITHIN 1.5 MILES RADIUS SURROUNDING THE ZONING JURISDICTION OF THE VILLAGE OF MANSFIELD.

LOCATED IN THE COUNTY OF PIATT, STATE OF ILLINOIS

NOW THEREFORE, BE IT ORDAINED, the Board of Trustees of the Village of Mansfield, Piatt County, Illinois as follows:

Section One - Wind Farms and Electric-Generating Devices Prohibited
No wind farms and electric generating wind devices are prohibited within the 1.5 mile radius surrounding the zoning jurisdiction of the Village of Mansfield.

Section Two - Penalties
The penalties for the violation this ordinance shall be in accordance with the all applicable provisions of the village code, and any applicable actions, remedies and penalties available through applicable state or federal law, at law or equity.

Section Three - Effective Date
This ordinance shall be effective within 10 days of its passage.

WHEREAS, the corporate authorities have the power to regulate wind farms and electric generating wind devices within the 1.5 mile radius surrounding its zoning jurisdiction pursuant to 65 ILC 5/11-13-26.

WHEREAS, the corporate authorities held a public hearing on this ordinance pursuant to the notice and hearing requirements of 65 ILCS 5/11-13-26.

WHEREAS, the corporate authorities, after said hearing and input from the public, have determined it is in the best interest of the health and welfare of the residents of Mansfield that wind farms and electric-generating wind devices should NOT be placed within 1.5 mile radius surrounding the zoning jurisdiction of the Village of Mansfield

NOW THEREFORE, BE IT ORDAINED, the Board of Trustees of the Village of Mansfield, Piatt County, Illinois as follows:

Section One – Windfarms and Electric Generating Devices Prohibited

It is declared that wind farms and electric generating wind devices are prohibited within the 1.5 mile radius surrounding the zoning jurisdiction of the Village of Mansfield.

Section Two - Penalties

The penalties for the violation this ordinance shall be in accordance with the all applicable provisions of the village code, and any applicable actions, remedies and penalties available through applicable state or federal law, at law or equity.


Section Three – Effective Date
