ANNUAL TAX LEVY ORDINANCE

AN ORDINANCE FOR THE LEVY OF TAXES FOR TAX YEAR 2019  
FOR THE VILLAGE OF MANSFIELD, IN PIATT COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees of the Village of Mansfield, in Piatt County, Illinois, heretofore adopted an Annual Appropriation Ordinance for the Village of Mansfield, for the fiscal year commencing on the 1st day of May, A.D., 2019, and ending on the 30th day of April, A.D., 2020, which said Ordinance was duly approved by the President and the Board of Trustees of said Village, and duly published as required by law.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Mansfield, in Piatt County, Illinois, at a regular meeting duly assembled:

**SECTION 1: GENERAL CORPORATE FUND.** That the sum of THIRTY-ONE THOUSAND DOLLARS AND NO CENTS (\$31,000.00) be and IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of the statute in such case made and provided, for the items and the amounts enumerated as follows, to-wit:

**SECTION 2: ILLINOIS MUNICIPAL RETIREMENT FUND (IMRF).** That the sum of SEVENTEEN THOUSAND TWO HUNDRED FORTY-SIX DOLLARS (\$17,246.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of 40 ILCS 5/7-171, as amended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 3: POLICE PROTECTION FUND.** That the sum of EIGHT THOUSAND NINE HUNDRED SIXTY DOLLARS AND NO CENTS (\$8,960.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 4. and in the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of 65 ILCS 5/8-8-8, as amended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 5: LIABILITY INSURANCE FUND.** That the sum of TWENTY SEVEN THOUSAND DOLLARS AND NO CENTS (\$27,000.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of 745 ILCS 10/9-107, as amended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 6: EMERGENCY SERVICES FUND.** That the sum of TWO HUNDRED FIFTY DOLLARS AND NO CENTS (\$250.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of 745 ILCS 10/9-107, as amended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 7: SOCIAL SECURITY FUND.** That the sum of THREE THOUSAND DOLLARS (\$3,000.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended and collected in accordance with the provisions of 40 ILCS 5/21-110, as amended, for the items and the amounts enumerated as follows, to-wit:

**SECTION 8: ROAD AND BRIDGE TRANSFER FUND.** That the sum of ZERO DOLLARS (\$0.00) BE AND IT IS HEREBY LEVIED upon all taxable property (including railroad property) within said Village of Mansfield, as the same is assessed and equalized for the following specific purposes mentioned in the said appropriation ordinance and in the respective amounts as follows, and said taxes shall be extended, for the items and the amounts enumerated as follows, to-wit:



**SECTION 9:** That the total amount of property tax for all corporate purposes, legally, made to be collected by tax levy for the current fiscal year, is the sum of NINETY ONE THOUSAND FIVE HUNDRED TWENTY-TWO DOLLARS AND NO (\$91,522.00).


**SECTION 10:** That a duly certified copy of this Ordinance shall be filed with the County Clerk of Piatt County, Illinois as is provided by law.

**SECTION 11:** That this Ordinance shall be known as the "Annual Tax Levy Ordinance for Tax Year 2019 for the Village of Mansfield, in Piatt County, Illinois", and shall be in full force and effect from and after its adoption, passage and approval.

**TRUTH IN TAXATION**

**CERTIFICATE OF COMPLIANCE**

This applies to the tax levy for the year 2019 payable 2020.

I, the undersigned, hereby certify that I am the presiding officer of the **Village of Mansfield**, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the Truth in Taxation law.

Check One of the Choices Below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- 2) The taxing districts aggregate levy did not exceed a 5% increase over the prior years extension. Therefore, a notice and a hearing were not necessary.
- 3) The proposed aggregate levy did not exceed a 5% increase over the prior years extension. Therefore, a hearing was not held.
